SUBJECT: Climate Action Plan Progress Report

TO: Council Information Package – July 5, 2024

FROM: Environment and Energy

PURPOSE:

The purpose of this report is to provide a progress update on the implementation of the Climate Action Plan, providing a pathway to reduce community-based greenhouse gas emissions to meet the target for Burlington to be net carbon neutral by 2050.

The City also has two other climate plans where annual progress reports are presented to Council:

- Climate Resilient Burlington a Plan for Adapting to Warmer, Wetter and Wilder Weather (EICS-05-24)
- Corporate Energy and Emissions Management Plan (EICS-08-24) Note: an updated plan is being presented for approval at the July 8th Committee of the Whole meeting.

Background and Discussion:

On April 23rd, 2019 council declared a <u>climate emergency</u> and one year later approved the Burlington <u>Climate Action Plan</u> (CAP). This report provides an update on the progress made to date to implement the CAP. The seven program areas identified in the CAP were based on modelling and actions that are needed for Burlington to meet the 2050 target to be a net carbon neutral community. Many of the actions in the plan focused on program development. The next version of the CAP will need to focus on scaling up actions to meet emission reduction targets, such as Better Homes Burlington and the Integrated Mobility Plan.

Strategy/process/risk:

Energy (electricity and natural gas) consumption data is collected from <u>Burlington Hydro</u> and <u>Enbridge Gas</u> Inc. to calculate greenhouse gas emissions across the community. Transportation emissions are more challenging to calculate – historically the City has relied on fuel sales data in Burlington for gasoline and diesel consumption. However, this method is imperfect as it does not capture fuel purchased in other municipalities by Burlington residents and, therefore, is considered as an indicator of emissions from the transportation sector.

Provincial policy decisions can impact our ability to reduce greenhouse gas emissions at the local level. For example, decisions to shift the production of electricity to natural gas fired generating stations to replace the loss of generation from decommissioned nuclear power plants will impact our rate of reducing emissions.

Secondly, the provincial government regulates local distribution companies through the Ontario Energy Board and decisions do not always support local climate action initiatives.

Third, many of the climate actions related to mitigating greenhouse gas emissions relies on increasing demand for electrical power. Burlington Hydro also has an important role to play in ensuring that the local distribution grid has the capacity to meet growing demand during the electrification transition for electric vehicles, thermal energy (air source heat pumps), renewable energy, energy storage (batteries) and bi-directional charging, etc. A Burlington Hydro report is also on the Committee of the Whole agenda (EICS-12-24) as they consider climate implications in future plans (electrification as well as climate resilience).

Lastly, there is a change management risk where community climate actions rely on residents, businesses, institutions and government to change behavior and choose measures that reduce greenhouse gas emissions, such as: air source heat pumps, active and sustainable transportation options, electric vehicles, solar panels and/or

battery storage. Community engagement initiatives and incentive programs from all levels of government and key stakeholders are necessary to continue momentum. As part of the risk management process, an audit was also completed of the three climate plans in 2023 with recommendations related to improving work plans, key performance indicators (KPIs) and financial resources. Staff are working through the recommendations and provide quarterly progress updates to the City's auditor.

Options Considered:

The Climate Action Plan provides a pathway to meet the Burlington target to become a net carbon zero community by 2050. Although many of the CAP measures identified in the plan are noted as complete, or partially complete, the next version of the CAP will need to focus on scaling up actions and programs to achieve the 2050 target.

Financial Matters:

The Climate Action Plan is due to be updated in 2025 as per a five-year cycle. Building on the momentum of the past five years, the plan will be updated with in-house staff resources. It will include an inventory of current actions with recommended next steps to scale up programs.

Climate Implications:

The City has set a target for the community to be net carbon neutral by 2050. Emissions have increased slightly as the economy is returning to business as usual and commuting has increased. Approximately half a million tonnes needs to be reduced between now and 2030 to work towards the overall target for 2050. Climate data for Burlington is provided in Appendix A.

Engagement Matters:

In 2023, the Burlington Climate Stakeholder Action Team (BCAST) updated its terms of reference and includes stakeholders from across the community. See Appendix B for a list of stakeholders and an update from the Region of Halton. The Team provides guidance and feedback on the implementation of the City's three climate plans: the Climate Action Plan; Climate Resilient Burlington: A Plan for Adapting to Warmer, Wetter and Wilder Weather; and the Corporate Energy and Emissions Management Plan.

In 2023 Council approved funding support for <u>BurlingtonGreen</u> (<u>EICS-02-24</u>) and its coordination of volunteers to engage residents and businesses across from community

on climate action and environmental sustainability initiatives. A summary of BurlingtonGreen's work in 2023/24 is provided in Appendix C.

Council also re-iterated its commitment to providing funding support to the <u>Bay Area Climate Change Council</u> (<u>EICS-04-24</u>), a collective of stakeholders across Burlington and Hamilton, focused on research, advocacy and community engagement.

Other collaboratives staff participate in to support climate action includes the <u>Clean Air Partnership and Council</u>, the <u>Global Covenant of Mayors</u> (Canada), <u>ICLEI</u> – Local Governments for Sustainability (Canada), the <u>Carbon Disclosure Project</u>, and <u>Partners for Climate Protection</u> (Federation of Canadian Municipalities). Community engagement is ongoing through the <u>TakeActionBurlington.ca</u> blog and <u>GetInvolvedBurlington.ca</u>.

Conclusion:

Meeting the community target for Burlington to be net carbon neutral by 2050 requires commitment and action from all levels of government, non-government organizations, businesses, community groups and individuals. Implementation of the Climate Action Plan and associated initiatives will take continued investment by the City, its partners and community at large to be successful at our transition to be a low carbon community.

Appendix A - Burlington Climate Data Summary




Figure 1 – Community Greenhouse Gas Emissions by Year Showing 2050 Target

The City has set a target for the community to be net carbon neutral by 2050. Figure 1 shows total community greenhouse gas emissions by year. Emissions have increased slightly as the economy is returning to business as usual and commuting has increased. Approximately half a million tonnes needs to be reduced between now and 2030 to work towards the overall target for 2050.

Figure 2 shows annual community emissions broken down by year and by source (natural gas, electricity and transportation). Emissions from natural gas consumption are down from 2022 but slightly higher than 2023. Natural gas emissions peaked in 2015 at just under 600,000 equivalent tonnes of carbon dioxide (eCO2) compared to 2023 at just under 500,000 tonnes. Consumption of natural gas is weather dependent but can be decreased by energy efficiency measures and switching to electric air source heat pumps, among other actions.

Transportation emissions have been increasing since 2020 as business as usual occurs with commuting, however, emissions are still lower than the peak in 2019. Electricity emissions increased slightly from 2022 which could be attributed to an increased reliance on natural gas fired electricity peaking stations as nuclear plants are upgraded.

Figure 2 – Community Annual Emissions by Source




Figure 3 – Community Emissions by Source (Percentage)

Figure 3 shows a breakdown of 2023 community emissions by source (transportation, electricity and natural gas) as a percentage. The percentage breakdown did not change from 2022. As illustrated, the consumption of natural gas and transportation fuels are the main source of emissions in the community.




Figure 4 – Annual Community Emissions by Sector (eCO2)

Figure 4 shows annual community emissions by sector (residential; commercial and institutional, industrial and transportation). This chart shows the impact of phasing out coal fired electricity generating stations in Ontario between 2000 and 2011. Since 2011, there has been a fairly steady reduction in emissions with some exceptions.





Figure 5 - 2021 Emissions by Sector (Percentage)

Figure 5 shows a breakdown of 2021 community emissions by sector (transportation, residential, commercial and institutional, and industrial) as a percentage.

The following chart summarizes distributed energy generation installed in the City based on numbers and generating capacity. With the exception of 290 kilowatts generated through four combined heat and power systems, there is just under 9,000 kilowatts installed capacity of renewable energy, the majority being solar.

The graph below illustrates net metered solar installations since before 2017 up until the time of report writing. The graph does not include solar installed under the provincial Feed-in Tariff (FIT) programs. Net metering allows customers to send electricity generated from renewable energy to Burlington Hydro's distribution system for a credit towards electricity costs. There are 76 net metered solar installations each less than 10 kilowatts in capacity and six net metered installations which are each greater than 10 kilowatts. The most recent large rooftop installation (250 kilowatts) was completed by Emshih Developments at 901 Guelph Line.

EXECUTIVE SUMMARY

The City of Burlington and BurlingtonGreen activated a fees-for-services Agreement March, 2023 to advance various strategic priorities of the City. \$70,000 was provided from the City's Community Development Fund to be utilized throughout the year for BurlingtonGreen's provision of extensive programming activities and environmental services across 5 subject areas:

- 1. Sustainable Transportation
- 2. Complete Communities
- 3. Urban Nature
- 4. Zero Waste
- 5. Community Engagement at the Eco Hub

With an impact outcomes focus, service agreement deliverables with associated KPIs were established and agreed upon, with impressive results presented in the following summary report. The far-reaching work accomplished has resulted in restored habitat, reduced greenhouse gas emissions, strengthened local biodiversity, cleaner creeks, parks and neighbourhoods, the diversion of tonnes of waste from the landfill and a more engaged and empowered community. This work has further advanced the goals of various city plans (Climate Action Plan, Climate Resilient Burlington, Urban Forest Management Plan, Integrated Mobility Plan, Get Involved Burlington).

All Agreement deliverables were completed with additional 'value added' initiatives contributed by BurlingtonGreen during the year such as the provision of extensive volunteer opportunities for the community and the implementation of various educational demonstration features at/by the BurlingtonGreen Eco Hub.








Please be advised that Brantford City Council at its meeting held June 25, 2024 adopted the following:

12.2.7 Support for the Decision of the Ontario Energy Board to End the Gas Pipeline Subsidy

WHEREAS residents are struggling with energy bill increases and need relief; and

WHEREAS natural gas is no longer the cheapest way to heat homes because electric heat pumps are now much more efficient, can provide all heating needs even in cold climates, and result in far lower energy bills over the long term compared to gas heating; and

WHEREAS natural gas is methane gas, which is a fossil fuel that causes approximately one-third of Ontario's GHG emissions, and must be phased out because it is inconsistent with all climate targets, while heat pumps result in the lowest GHG emissions and are consistent with a zero-carbon future; and

WHEREAS the Ontario Energy Board (OEB) decided to end a subsidy for methane gas pipelines to be built in new construction developments, effective 2025, finding that this would lower energy bills for existing gas customers and improve affordability for new homebuyers, but this decision is at risk of being overturned by the provincial government; and

WHEREAS the OEB decision will help lower energy bills and encourage heating systems that are consistent with climate targets and plans; and

WHEREAS the construction of new methane gas pipelines, which have 60-year targets and will result in higher carbon emissions, higher energy bills, higher future decarbonization retrofit costs to get off fossil fuel heating, and a continued financial drain as dollars leave the province to pay for fossil fuels extracted in other jurisdictions; and

WHEREAS the City of Brantford declared a climate emergency in 2019; and

WHEREAS transforming buildings by supporting actions that improve their energy efficiency aligns with the goals outlined in Brantford's Climate Change Action Plan.

NOW THEREFORE BE IT RESOLVED:

- A. THAT the City of Brantford EXPRESS its support for the decision of the Ontario Energy Board to end the gas pipeline subsidy and RESPECTFULLY REQUESTS that the Ontario Government allow the decision to stand; and
- B. THAT this resolution BE CIRCULATED to the President of the Association of Municipalities of Ontario, Colin Best; Premier of Ontario, Doug Ford; Minister of Energy, Todd Smith; Minister of Finance, Peter Bethlenfalvy all Ontario Municipalities, The Honourable Marit Stiles, Leader of the Official Opposition, and The Honourable Bonnie Crombie, Leader of Ontario Liberal Party.

Re: Regulations for the Importation and Safe Use of Lithium-ion Batteries

I am writing today to bring to your attention a matter of significant importance to the Township of Otonabee-South Monaghan, regarding the importation and safe use of lithium-ion batteries.

At the June 17, 2024 Council Meeting the Fire Chief of the Township of Otonabee-South Monaghan made a presentation to Council on the dangers presented by lithium-ion batteries. The Fire Chief was reporting back from attending the Charged For Life Symposium presented by the Office of the Fire Marshal.

During the presentation, the Fire Chief stressed that the increased importation and use of non-Original Equipment Manufacturer (OEM) aftermarket batteries is presenting a significant increase in fire and explosion, putting citizens and responding personnel in danger. These after market batteries are not Underwriter Laboratories of Canada (ULC) certified but can be imported into Canada without any associated regulations.

Unlicensed persons and locations can store and modify lithium-ion batteries in our communities without regulations, providing dangerous conditions within a community. Charging these batteries within the home or multi-unit dwellings can result in larger fires with grave results.

As Canada becomes more aware of Green Energy solutions, these batteries are used more often, increasing the danger to our communities. We support the Ontario Fire Marshal's program to educate citizens on the danger associated with lithium-ion batteries and encourage every municipality to actively promote safe practices for the use of lithium-ion batteries.

We also call upon all levels of government to enact regulations for the importation, sale, storage, and use of non-OEM or ULC certified lithium-ion batteries.

Dear Premier Ford.

At its meeting held on April 8, 2024, St. Catharines City Council approved the following motion:

WHEREAS Ontario has more private non-native ("exotic") wild animal keepers, roadside zoos, mobile zoos, wildlife exhibits and other captive wildlife operations than any other province; and

WHEREAS the Province of Ontario has of yet not developed regulations to prohibit or restrict animal possession, breeding, or use of non-native ("exotic") wild animals in captivity; and

WHEREAS non-native ("exotic") wild animals can pose very serious human health and safety risks, and attacks causing human injury and death have occurred in the province; and

WHEREAS the keeping of non-native ("exotic") wild animals can cause poor animal welfare and suffering, and poses risks to local environments and wildlife; and

WHEREAS owners of non-native ("exotic") wild animals can move from one community to another even after their operations have been shut down due to animal welfare or public health and safety concerns; and

WHEREAS municipalities have struggled, often for months or years, to deal with non-native ("exotic") wild animal issues and have experienced substantive regulatory, administrative, enforcement and financial challenges; and



WHEREAS the Association of Municipalities of Ontario (AMO), the Association of Municipal Managers, Clerks and Treasurers of Ontario (AMCTO) and the Municipal Law Enforcement Officers' Association (MLEOA) have indicated their support for World Animal Protection's campaign for provincial regulations of nonnative ("exotic") wild animals and roadside zoos in letters to the Ontario Solicitor General and Ontario Minister for Natural Resources and Forestry;

WHEREAS the Province of Ontario has of yet not developed regulations to prohibit or restrict animal possession, breeding, or use of non-native ("exotic") wild animals in captivity; and,

WHEREAS non-native ("exotic") wild animals can pose very serious human health and safety risks, and attacks causing human injury and death have occurred in the province: and.

WHEREAS the keeping of non-native ("exotic") wild animals can cause poor animal welfare and suffering, and poses risks to local environments and wildlife; and.

WHEREAS owners of non-native ("exotic") wild animals can move from one community to another even after their operations have been shut down due to animal welfare or public health and safety concerns; and.

WHEREAS municipalities have struggled, often for months or years, to deal with nonnative ("exotic") wild animal issues and have experienced substantive regulatory, administrative, enforcement and financial challenges; and,

AND WHEREAS the Association of Municipalities of Ontario (AMO), the Association of Municipal Managers, Clerks and Treasurers of Ontario (AMCTO) and the Municipal Law Enforcement Officers' Association (MLEOA) have indicated their support for World Animal Protection's campaign for provincial regulations of non-native ("exotic") wild animals and roadside zoos in letters to the Ontario Solicitor General and Ontario Minister for Natural Resources and Forestry;

Enbridge Gas Inc. has applied to dispose of the balances of certain deferral and variance accounts.

If the application is approved as filed, then a typical residential customer and a typical general service customer of Enbridge Gas Inc. would see the following one-time billing adjustments, effective January 1, 2025:

EGD Rate Zone (former Enbridge Gas Distribution Inc. customers)

 Residential Rate 1 Sales Service and Direct Purchase customers will see a onetime billing credit of \$5.12, effective January 1, 2025.

<u>Union Rate Zone (former Union Gas Limited customers)</u>

- Union South Residential Rate M1 Sales Service customers will see a one-time billing charge of \$9.51, effective January 1, 2025.
- Union South Residential Rate M1 Direct Purchase customers will see a one-time billing charge of \$1.60, effective January 1, 2025.
- Union North-West Residential Rate 01 Sales Service and Direct Purchase customers will receive a one-time billing charge of \$0.13, effective January 1, 2025.
- Union North-East Residential Rate 01 Sales Service and Direct Purchase customers will see a one-time billing charge of \$0.47, effective January 1, 2025.

Other customers, including businesses, may also be affected. It is important to review the application carefully to determine whether you may be affected by the proposed changes.

Under the OEB-approved Earnings Sharing Mechanism, Enbridge Gas Inc. is required to share with customers any earnings that are 150 basis points over the OEB-approved return on equity. Enbridge Gas Inc. says that its 2023 earnings were below the 150 basis point threshold and as a result it is not proposing to share any earnings with customers.

RE: Request for Royal Assent of Administrative Monetary Penalty System in the Ontario Building Code Act.

The Administrative Monetary Penalty System (AMPS) is an enforcement tool approved by the Provincial Government in August of 2009 and was originally used for parking offences to free up court time and cost.

A large number of municipalities have adopted an AMPS program and have applied AMPS to other Municipal enforcement by-laws as a replacement to the standard Part 1 Provincial Offences Act (POA) ticket system, as it provides the alleged offender with a flexible appeal system and the municipality the ability to apply unpaid penalties on to the property taxes. AMPS frees up valuable Provincial Offences Court time saving the province and the municipalities valuable resources and funds.

AMPS was written into the Building Code Act in December of 2017 however it has not received Royal Assent. AMPS has proven to be a valuable tool for education and enforcement of other Municipal by-laws. On behalf of the Council of the Corporation of the Township of Lake of Bays, we ask that AMPS receive Royal Assent. In doing so this would free up time for Building Officials to conduct their primary job (building inspections) instead of having to attend court normally a full day to hear an appeal to Part 1 ticket, at the same time providing the offender a more streamlined appeal system.


