Low-Income Seniors and Persons with Disabilities Property Tax Reduction Program

To qualify:

All applicants must meet the following requirements:

- Be the assessed owner and occupant of a residential property in the City of Burlington for at least one year before the application is submitted.
- Property is owner's principal residence.
- Owner or spouse is a registered owner(s) of only one property in the City of Burlington.

Program specifications:

- No more than one reduction shall be granted on a property in a given year.
- An application must be submitted each year by December 31.
- Have paid property taxes in full.
- Reminder- No refunds will be issued. Reduction of \$575 will be applied to the property tax account after the September installment.

Low-Income Seniors:

Owner and/or spouse must:

- Be 65 years of age or older.
- Be in receipt of the Guaranteed Income Supplement (GIS) pursuant to the Old Age Security Act.
- Submit prior year T4A(OAS) slip reflecting payments in Box 21 or GIS Entitlement letter.

Low-Income Persons with Disabilities:

- Owner is in receipt of income support paid under the Ontario Disability Support Program Act.
- Submit prior year T5007 Statement of Benefits reflecting payments in Box 11.
- Submit confirmation from the Ministry of Children, Community and Social Services indicating receipt of income support under the Ontario Disability Support Program (ODSP).
