

Street Improvements in the Rexway Drive Area

Project Update – November 2019

Project Schedule

Water and wastewater servicing work on Rexway Drive, from Cumberland Avenue to Ronald Drive, will continue and be completed by the end of 2019. We intend to complete all curb and sidewalk replacement, as well as base asphalt works before the end of the year. If unseasonal temperatures remain, temporary works will take place. Areas that require landscaping will receive grading and topsoil only. Sod, final restoration, and top asphalt on Rexway Drive will be completed in 2020.

Snow Removal and Maintenance

Snow removal on Rexway Drive, including sidewalks, will be carried out by our Contractor within the construction area until base or temporary asphalt has been completed.

Winter Construction Shutdown

Active construction will pause during the winter months. We expect the shutdown to take place from January until early Spring of 2020, weather dependant.

Traffic Interruptions

During underground servicing, concrete works, paving, and landscaping Rexway Drive will continue to have interruptions to vehicular traffic, as traffic will not be unable to go past construction equipment, trucks, and open excavations. Day-to-day direction to drivers will be provided through the means of on-site staff and signage.

<u>Parking</u>

For the duration of construction when your driveway is inaccessible or closed, please park on neighbouring streets or Rexway Drive where no construction is taking place and register your vehicle for the On-Street Parking Exemption Program at:

- 905-335-7844 24-hour voice message.

How does a parking exemption work?

- It allows a vehicle to park on the street beyond the 5-hour limit or overnight between 1 a.m. to 6 a.m., up to 15 days per calendar year, per license plate.
- The only two parking offences waived AFTER a vehicle is registered for a parking exemption are:





- 1. park exceeding 5-hour limit
- 2. park between 1 a.m. to 6 a.m.
- All other parking offences apply as they are not part of the parking exemption program.
- During a snow event on street parking exemptions are cancelled.

During City construction projects.

- The extra days will not be included in the 15-day per year limit when your driveway is not accessible.
- However, it is important to register your vehicle for this program so that you will not receive a parking ticket.
