- Letter from Employer verifying employment
- Photos (passport/photo booth - minimum 2)
- Medical Certificate from a physician qualified to practice in the Province of Ontario, dated within thirty (30) days of the date of application, certifying that the Attendant is free from communicable diseases and is medically fit to perform Body-rubs
- Proof of legal entitlement to work in Canada  
Must be one of the following items:  
Canadian Birth Certificate, valid Canadian passport, Certificate of Citizenship, Permanent Resident Card, Landed Immigrant Status, valid work permit
