**Tuck Creek Flood Assessment and Crossing Upgrades
Between New Street and Spruce Avenue**

Please be advised that the City of Burlington has completed the Environmental Assessment process for the above-noted project under Schedule B of the Municipal Class Environmental Assessment. The study was undertaken to develop, evaluate, and recommend preferred alternatives for flood remediation on Tuck Creek between New Street and Spruce Avenue. A public information meeting was held on November 30, 2015. A set of alternative solutions was presented and comments were received.

Requests for a Part II Order must be received by the Minister in writing at the address provided below. A copy of the request must also be sent to the City Clerk. If no request is received by July 23, 2016, the City of Burlington intends to proceed with the detailed design and construction of this project.

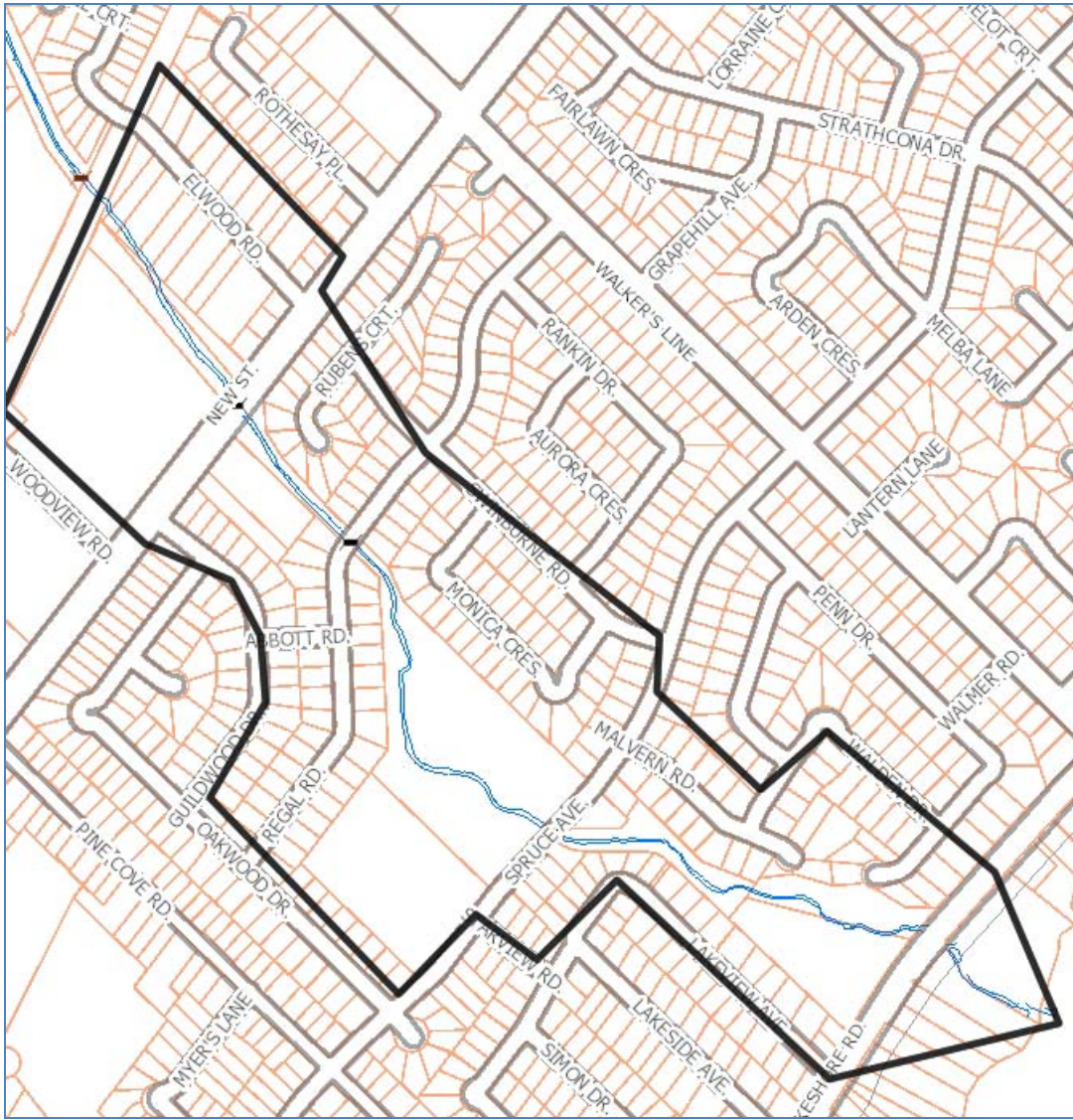
