| Qualification Criteria | Permit is for passenger vehicles only in a residential area (excludes the rural area). Resident must provide proof that all vehicles are registered to their address. Permit will be issued to one licence plate. |
| Fees | \$30 per month (includes HST) \$350 per year (includes HST) |
| Electronic Permit Use | Allows vehicle to park: <ul style="list-style-type: none"> ○ on any residential street parallel to the curb-line in the Ward boundary ○ up to 48-hours on the street in the same location ○ beyond the 5-hour limit, between 1am-6am and during snow removal activity. |

| Exclusions | Permit does not allow vehicle: <ul style="list-style-type: none">○ that is inoperable or immobile to park on the street○ to park on the street in the same location for more than 48-hours. Permit will not be issued to large vehicles, recreational vehicle, school bus, trailer, etc. |
| Plate Changes | Notify Parking Services of licence plate changes at Parking@Burlington.ca. |
| Renewal | Renewals must be made <u>PRIOR</u> to the permit expiry date. Payment options are: <ul style="list-style-type: none">○ in person at Service Burlington, City Hall, 1st floor○ by phone at 905-335-7816 (credit card payment only). |
| Refund | Will be processed upon receipt of your information sent to Parking@Burlington.ca. Refunds are issued for the value of the permit that is calculated from the cancel date. |
| Cancellation | The City reserves the right to cancel a permit at any time for improper use of the permit. |
| Personal Information | The collection, use and disclosure of personal information are governed by the <i>Municipal Freedom of Information and Protection of Privacy Act, R.S.O. 1990, c. M.56.</i> |
