8.1.3(2)(g)	Additional wording has been added to this policy to guide the implementation of the transportation policies of Chapter 6 of the adopted Official Plan through the consideration of development applications in Mixed Use Nodes and Intensification Corridors. 8.1.3(2)(p)	A new policy has been created to clarify how objective 8.1.3(1)(f) will be implemented through the review of development applications.
